

The **Photographic Association of Extremadura (eXTRE-FOTO)**, as part of the 2016 Cáceres Festival, is organising the **4th International photography contest** with the following terms.

TERMS:

FIRST | PARTICIPANTS

This is an INTERNATIONAL contest, and is open to amateurs and professionals all over the world. It is sponsored by CEF: N° E/2016/15, and as such it shall follow its rules and count towards its honorary degrees.

Members of the Directive Board of the Photographic Association of Extremadura (eXTRE-FOTO) and their first degree family members are not allowed to participate in the contest. In case the participant is a minor, they must have the express authorisation of their parents or legal guardians.

SECOND | SECTION | THEME

The contest shall have two sections:

- A.- Free choice
- B.- Theme: Extremadura

The choice for both the theme and the technique shall be free in section (A). Section (B) shall only allow photographs related to the theme "Extremadura", the choice on technique and treatment being free.

THIRD | WORK

- Each participant may submit a maximum of three (3) photographs for each section.
- All photographs must have been taken by the participant and may not include elements created by other people.
- The images must be in JPG format, with sizes no larger than 1980px horizontally, 1080px vertically and with a file size no larger than 1Mb. It is recommended that the colour space is sRGB and the original file must have a minimum size of 4200px by 2800px with a resolution of 240 pixels per inch to guarantee an optimum printing quality.
- A single photograph may not be submitted to more than one section.
- Photographs that have won a prize or been selected in previous issues of this contest may not be submitted.
- The organisers reserve the right to refuse or exclude from the contest any photograph that may have contents that go against the right to honour, personal or family intimacy or anyone's individual image rights. In conclusion, no photograph shall be accepted if it is against the current legislation.



FOURTH | INSCRIPTION AND SUBMISSION

There is an inscription fee of 15€ which allows the participant to submit work in all sections. Participants who are members of associations shall have a 10% discount for groups of 5 to 10 participants and 15% for larger groups.

Inscription, submission of the images and payment of the entry fee shall be done through the website: <http://www.extrefoto.com> and the payment method shall be through PayPal. Bank transfers are allowed only in exceptional cases (the added cost of which shall be the responsibility of the participant), after which a copy of the receipt must be sent via email to concursos@extrefoto.com.

FIFTH | SUBMISSION TERM

The term for submitting the photographs ends on **23th of October 2016**.

SIXTH | PRIZES

- For section A:
First prize: 1.000 € + CEF gold medal
Second prize: 500 € + CEF silver medal
Third prize: CEF bronze medal
- For section B:
FIRST PRIZE: 500 € + CEF GOLD MEDAL
SECOND PRIZE: 250 € + CEF SILVER MEDAL
THIRD PRIZE: CEF BRONZE MEDAL

The authors of winning photographs shall be notified through the e-mail address provided for the purpose of communication. Each participant may receive a maximum of one prize.

The payment of the prize is subject to the Spanish tax laws in force at the moment, regardless of the winner's country of residence.

The winners may receive the prize amount via bank transfer or through a money transfer service. Any fees shall be paid by the receiving account.

SEVENTH | JURY

There shall be an entry jury, made up of members of the Photographic Association of Extremadura (eXTRE-FOTO) who shall ensure that these terms are applied correctly in the works, and may refuse those that do not meet the terms. If necessary, the jury may ask the participant to provide more data to justify the relationship with the theme for works submitted in section B ("Extremadura").

The second jury, the "qualifying jury" shall have the at least one member of the Board of the Photographic Association of Extremadura (eXTRE-FOTO) and recognized professional photographers to be determined.



Said jury shall be responsible for the classification of the works, selection of the photographs to feature on the catalogue and for awarding the prizes described above.

The jury has the capacity to declare the contest void if the quality of the photographs does not meet an acceptable minimum.

The decision of the jury may not be appealed and shall be made public on the 4th of November 2016. Within a maximum term of one month starting on that date the organisers shall award the prizes.

EIGHTH | INTELLECTUAL PROPERTY RIGHTS

The authors are responsible of ensuring that there are no rights held by third parties and any claims for image rights.

The organisers shall compile a catalogue (be it printed, on CD, website, etc.) with the work of the 30 finalists with the sole purpose of broadcasting the Festival "Cáceres de Foto" which the contest is part of. An exhibition shall also be organised in Cáceres with said photographs, all the printing costs of which shall be covered by the organisers.

All other use of the photographs is excluded.

The rights of use, publishing, distribution, exhibition, public communication, broadcasting and reproduction of the winning works shall be held (non exclusively) by the Photographic Association of Extremadura (eXTRE-FOTO) in the territory (globally) for a period no longer than 15 years.

The printed copy of the winning photographs shall be part of the Photographic Association of Extremadura (eXTRE-FOTO) archives, and may be used for exhibitions in the future after notifying the author.

The non-winning selected copies shall be destroyed after the exhibition.

If deemed necessary, the author must submit the graphic material necessary for the correct reproduction of the work.

NINTH | ACCEPTANCE OF THE TERMS

By entering this contest the participant accepts each and every one of its terms as well as the decision of the jury which may not be appealed. The participant also declares to be in possession of all the necessary rights.

Any situation not foreseen by these terms shall be resolved by the Organising Commission.
